Minutes of the Pre-Bid Meetings

**Establishment Of Sardar Bahadur Khan Women's University Sub-Campus Khuzdar (Package 1 to 4)
(Held on December 21th 2021 at Conference Hall SBKWU)**

A pre-bid meeting was held on December 21, 2021 in conference Hall SBKWU regarding the above cited project. As per instructions in the bidding documents, the contractors were required to ask questions in writing regarding the project to clarify any ambiguity. None of the contractors came with written questions instead verbal questions were asked. The questions were verbally answered by the Project Director at the moment in presence of the contractors who participated. After detailed discussion, the project director intimated the contractors that these questions and their point wise replies will be documented as official record and will be uploaded on SBKWU website for transparency and equal intimation to the contractors. Identified questions and their point wise replies are briefly illustrated as under.

1. Question. How many copies of technical brochures are required.

Response: One original and two copies of technical brochures must be submitted as per bidding documents volume-I.

2. Question. Does the project belong to provincial PSDP or Federal PSDP.

Response: The project is a federally funded project monitored through HEC which is replicated in federal PSDP.

3. Question. Will BRA taxes be implemented or not?

Response: BRA taxes will be implemented as per BRA rules.

4. Question. The estimates of this project are based on CSR-2018 of Government of Balochistan, which is not workable anymore. Therefore, rates must be adjusted by keeping in view the current market price hike of materials.

Response: The competent authority of SBKWU had approved to follow the Composite schedule of rates (CSR-2018) of Government of Balochistan for preparation of BOQ and Engineering estimates. We are bound to follow the CSR-2018 rates until Government of Balochistan
